We are counsel to the Association of Power Producers of Ontario (“APPrO”) in the above-noted proceeding. On March 27, 2024, the Ontario Energy Board (“OEB”) issued a decision directing cost eligible intervenors to file their cost claims with the OEB. APPrO’s cost claim has been prepared and filed through the OEB’s online cost claim filing system in accordance with section 10 of the OEB Practice Direction on Cost Awards.

APPrO participated reasonably in the proceeding by focusing its involvement on issues directly relevant to its members. This ensured that its participation in the process would not unduly repetitive and was focused on relevant and material issues. APPrO further minimized its costs by having its president attend the relevant portions of the oral hearing.

APPrO’s participation contributed to a better understanding by the OEB of the issues in the proceeding. APPrO’s overall argument appeared to have been accepted in the OEB’s decision, particularly in relation to maintaining the current cost of capital framework. APPrO did not engage in conduct that tended to lengthen the process unnecessarily or engage in any inappropriate or irresponsible conduct.
