**Re: EB-2024-0063 – Generic Hearing on Cost of Capital – SEC Cost Claim**

We are counsel to the School Energy Coalition ("SEC"). Attached, please find SEC's cost claim using the OEB's cost claim system.

This was a complex and critically important proceeding for SEC and all participants. It involved extensive interrogatories and responses, the need for significant analysis and research, a six-day oral hearing, and two rounds of detailed written argument.

SEC actively coordinated during the proceeding with other customer groups, most extensively with CCC and AMPCO/IGUA. SEC and AMPCO/IGUA took the lead in cross-examining the utility experts and coordinated their respective focuses to avoid undue duplication. Furthermore, our detailed written submissions were referenced and relied upon by both AMPCO/IGUA and CME in their own submissions.

SEC notes that for categorization purposes, since there do not appear to be appropriate categories for the following activities, time spent preparing for the Issues Conference has been included under the 'Preparation of Issues List Submission' category. Similarly, time spent meeting and consulting with other ratepayer groups regarding the potential filing of expert evidence, as well as drafting the joint letter in support of the proposal filed by AMPCO/IGUA, has been included in the 'Review Procedural Documents' category.

SEC submits that its participation in this proceeding was thorough and valuable and was designed to maximize its assistance to the OEB. Accordingly, SEC requests reimbursement of its reasonably incurred costs as set out in this letter and the attached documentation. These costs are commensurate with the scope of the issues and the role SEC played in this proceeding.
