We are counsel to Canadian Manufacturers & Exporters (“**CME**”). Pursuant to the Board’s Decision and Order dated March 27, 2025, we have attached CME’s final cost claim in this proceeding.

CME respectfully requests an award of 100% of the listed eligible costs. CME’s representation was undertaken by two individuals in this case, Scott Pollock and O’Neal Ishimwe. CME ensured that there was no duplication by Mr. Pollock and Mr. Ishimwe, and have ensured that the costs are reasonable and appropriate. In this regard:

- In recognition of the fact that Mr. Ishimwe has not previously been counsel for an OEB matter, CME has voluntarily reduced its cost claim by approximately \$3,000.00 to account for the time necessary for counsel to become acclimated with an energy board proceeding;

We are counsel to Canadian Manufacturers & Exporters (“**CME**”). Pursuant to the Board’s Decision and Order dated March 27, 2025, we have attached CME’s final cost claim in this proceeding.

CME respectfully requests an award of 100% of the listed eligible costs. CME’s representation was undertaken by two individuals in this case, Scott Pollock and O’Neal Ishimwe. CME ensured that there was no duplication by Mr. Pollock and Mr. Ishimwe, and have ensured that the costs are reasonable and appropriate. In this regard:

- In recognition of the fact that Mr. Ishimwe has not previously been counsel for an OEB matter, CME has voluntarily reduced its cost claim by approximately \$3,000.00 to account for the time necessary for counsel to become acclimated with an energy board proceeding;
