- 6. Copies of all correspondence between Enbridge and the City of Guelph from May 10, 2024 to January 31, 2025;
- 7. Additional evidence regarding the City of Guelph's climate targets and energy transition commitments. Including but not limited to:
 - a. The City's Race to Zero climate pledge;
 - b. The City's Community Energy Plan; and
 - c. The City's Commitment to Achieve 100% Renewable Energy by 2050.
