## DECISION AND ORDER

Monarch LP (Monarch), ORS LP (ORS) and Aypa Power GL LP (Aypa Power) filed applications with the Ontario Energy Board (OEB) on March 7, 2025, under section 60 of the *Ontario Energy Board Act, 1998* (OEB Act), for new electricity storage licences to reflect ownership of existing storage facilities.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

Monarch filed its application for a licence to authorize it to own the MNR BESS battery storage facility located in Oakville, Ontario. The MNR BESS storage facility has been operational since August 2018.

ORS filed its application for a licence to authorize it to own the ORS BESS battery storage facility located in Ingersoll, Ontario. The ORS BESS storage facility has been operational since June 2019.

Aypa Power filed its application to authorize it to own the GLC BESS battery storage facility located in Woodbridge, Ontario. The GLC BESS storage facility has been operational since August 2019. All three of the storage facilities are currently operated by Aypa Power Canada LP.

After considering the applications and assessing the technical capability and financial viability of the applicants, the OEB finds that it is in the public interest to grant the applications and issue electricity storage licences to Monarch LP, ORS LP and Aypa Power GL LP. The OEB is also amending schedule 1 of Aypa Power Canada LP's electricity storage facility licence ES-2022-0092, to update the facility information for its operation of the energy storage facilities on behalf of the applicants.

The OEB notes that the applicants did not submit requests for licence authorization to own their respective storage facilities and the storage facilities have been operational without being authorized to do so. The granting of the licences is without prejudice to any future compliance actions in relation to Monarch LP, ORS LP and Aypa Power GL LP for operating without necessary OEB approved licences.

**IT IS ORDERED THAT:**

1. Monarch LP's application for an electricity storage licence is granted, on such conditions as are contained in the attached licence.
2. Aypa Power GL LP's application for an electricity storage licence is granted, on such conditions as are contained in the attached licence
3. ORS LP's application for an electricity storage licence is granted, on such conditions as are contained in the attached licence.
4. Schedule 1 of Aypa Power Canada LP's electricity storage licence ES-2022-0092 is amended to update the facility information for the applicants. All other conditions of the licence remains the same. The amended licence is attached.
