### Distribution Rates and Charges

Effective March 1, 2025, following approval from the Ontario Energy Board (OEB), we've updated our distribution rates. The new rates result in an increase to the total bill of 0.43% or \$0.57 per month for a typical residential customer with monthly consumption of 750 kWh.

Burlington Hydro Inc.'s distribution rates and services are regulated by the Ontario Energy Board, an independent provincial government agency. For more information, click the link to the full OEB [Final Rate Order](#).

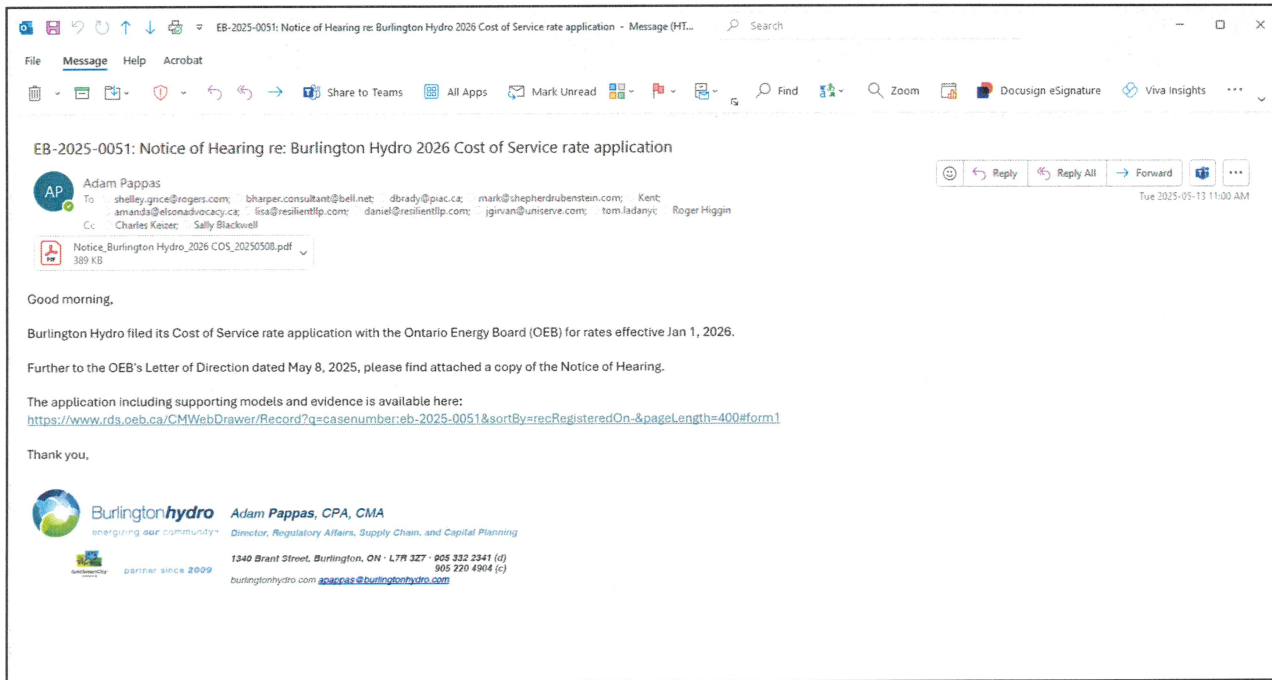



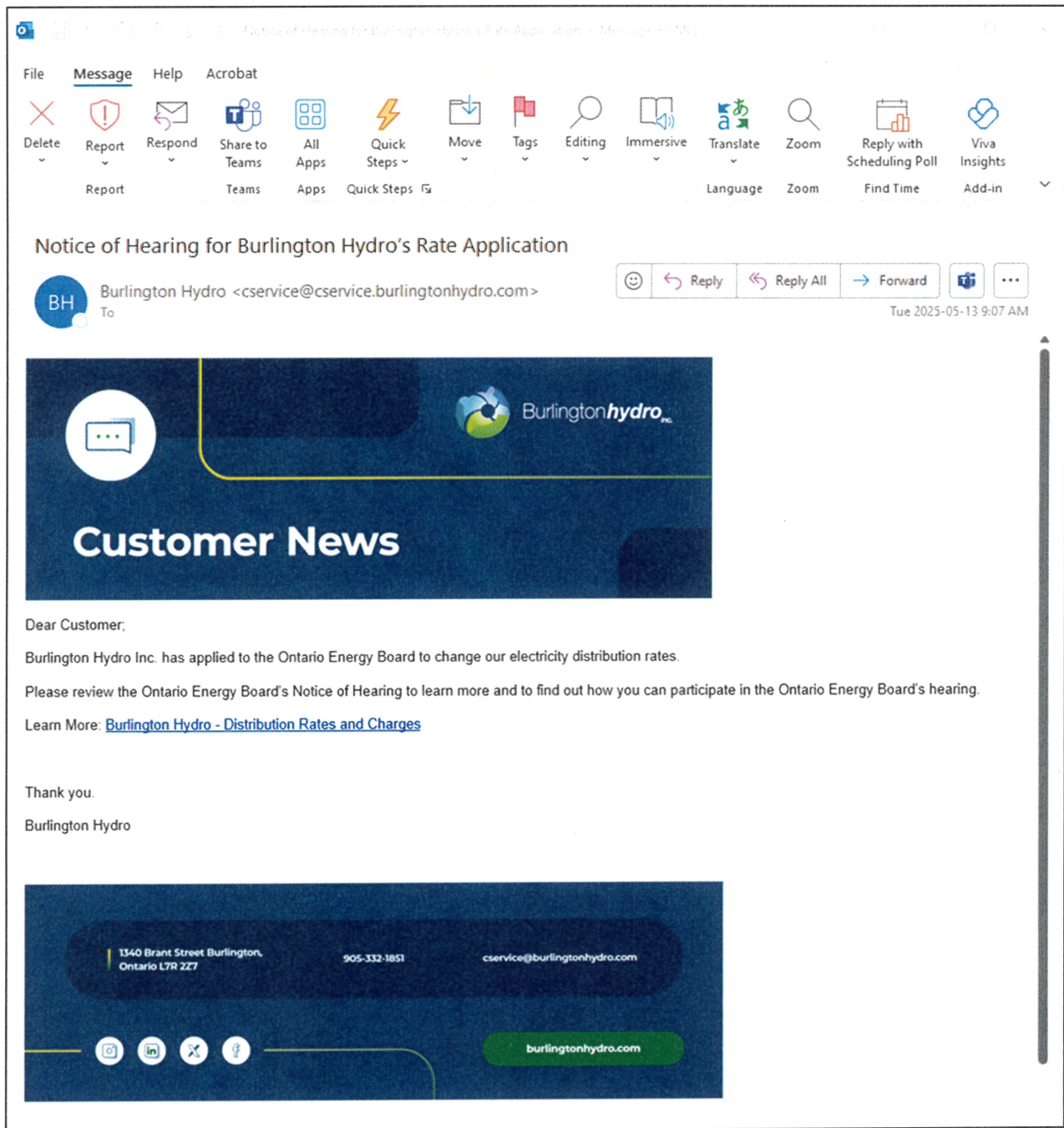

# NOTICE OF A RATE HEARING

### Burlington Hydro Inc. has applied to change its electricity distribution rates effective January 1, 2026

If the application is approved as filed, a typical residential customer and a typical general service customer of Burlington Hydro Inc. would see the following increase:

Residential (750 kWh)	\$9.84 per month
General Service less than 50kW (2,000 kWh)	\$17.81 per month

Other customers, including businesses, will also be affected.

Burlington Hydro Inc. has also applied for approval of a proposed Advanced Capital Module for the replacement of its existing supervisory control and data acquisition system and implementation of an advanced distribution management system and to dispose of certain deferral and variance account balances.

It is important to review the application carefully to determine whether you may be affected by the proposed changes.

#### YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as intervenors. After the hearing, we will decide whether to approve the application.

#### IMPORTANT DATES

You must engage with the OEB on or before May 26, 2025 to:

- Provide input on the hearing type (oral, electronic or written)
- Apply to be an intervenor

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.

#### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
