**EB-2025-0093 – Hydro One Networks Inc. St. Clair Transmission Line Project Expropriation Application – Affidavit of Service**

3. [REDACTED] which has been an inactive corporation since 1999 and has a registered interest No. [REDACTED] (registered on July 30, 1969) for an Assignment of oil and gas leases for a term of 10 years [REDACTED] is the original lease, not the assignment); and
4. [REDACTED] which has been inactive corporation since 2009 and has a registered interest No. [REDACTED] (registered on July 22, 1992) for a Petroleum and Natural Gas Lease and Grant for a term of 5 years;
5. [REDACTED] is an Ontario Corporation which was included in the Application erroneously and the Application will be amended to remove this entity.

Hydro One has undertaken reasonable and diligent efforts to locate an address for service for the individuals and entities listed above and which is further described in paragraph 8 of my Affidavit of Service which did not return any results. Based on the foregoing, Hydro One requests that no further steps be required for service of these interest holders.

**AFFIDAVIT OF ERYN MACKINNON**

**I, Eryn MacKinnon, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:**

1. I am employed as a Regulatory Advisor in the Regulatory Affairs Division of the Applicant, Hydro One Networks Inc. (“Hydro One”).
2. Hydro One has complied with the Ontario Energy Board’s Letter of Direction dated April 24, 2025, in respect of EB-2025-0093 (the “Letter of Direction”) as set out below.
3. In accordance with paragraph 1 of the Letter, Hydro One has conducted a title search sufficient to determine the current registered property owners and encumbrancers with lands or interests directly affected by the proposed expropriation application. I have been advised by those with knowledge of the matter and do verily believe that the search was completed in accordance with the Letter of Direction.
4. In accordance with paragraph 2 of the Letter, the following materials were sent on April 25, 2025, by courier and/or registered mail to each of the property owners and/or entities, that I was advised hold a direct or registered interest in lands that are the subject matter of this Application. The Notice package included:
  - The Notice of Hearing, as provided by the Ontario Energy Board;
  - The application, as filed by Hydro One Networks Inc. on April 4, 2025;
  - Applicable property descriptions and reference plans.

5. A list of the entities served is provided and attached as Exhibit "A" to this affidavit.
6. A copy of the courier and registered mail manifests are attached as Exhibit "B" to this affidavit.
7. A copy of the courier and registered mail proof of delivery receipts are attached as Exhibit "C" to this affidavit.
8. With respect to five (5) registered interest holders, Hydro One was unable to effect service on them in relation to the subject properties below. With respect to these registered interest holders, I am advised and do believe that Hydro One has taken reasonable steps to locate an address for the listed party to effect service in the manner prescribed in the Board's Letter of Direction. Despite these efforts which are described in the chart below, service could not be completed.
