Mandate and Objectives:

Community Action for Environmental Sustainability (CAFES) Ottawa is an independent not-for-profit organisation operating in the City of Ottawa. OEB Proceedings:

Issues:

CAFES Ottawa membership, our network of organizational representatives from across the City of Ottawa and our partnership organisations represent individual and business ratepayers

of Ottawa Hydro. We have a direct consumer interest in this proceeding and will be directly impacted from a collective financial and community perspective due to the outcomes of this proceeding.

Policy Interests:

CAFES Ottawa supports the development of our electricity distributor's system in a manner that provides cost-effective and reliable service while ensuring that Hydro Ottawa's delivery enables our city to benefit from the economic and clean energy options available through the energy transition. Prudent planning and investment are also required to support our City's energy and emissions objectives.

Hearings:

CAFES Ottawa does not have a preference.

Evidence:

CAFES Ottawa is not planning to file expert evidence.

Coordination with Other Intervenors:

CAFES Ottawa intends to coordinate with all stakeholders in this proceeding. We had an early discussion with Pollution Probe once the proceeding notice was published to determine the extent of potential commonality on the issues in the application. Our focus on a significant number of issues identified in the Hydro Ottawa application are distinctly different and there is limited overlap. However, CAFES Ottawa intends to coordinate with all stakeholders during this proceeding where there is commonality in interest and position on any specific issue.
