Issues:

Pollution Probe represents a direct consumer and policy interest related to the issues in this proceeding. Pollution Probe was a participant in the most recent Enbridge Gas Supply Plan review and recommended the approach that the OEB is applying for EB-2025-0065, which includes an adjudicated assessment of the Enbridge Five-year Gas Supply Plan. Issues to be considered include the appropriateness of the Gas Supply Plan and alignment with the OEB's Framework which includes consumer, environmental and economic impacts. Based on the OEB stakeholder consultation for this proceeding that Pollution Probe participated in, Pollution Probe also understands that the OEB will be considering whether adjustments should be considered for the OEB's Framework for the Assessment of Distributor Gas Supply Plans. It would be helpful to understand if the outcomes of this proceeding will result in changes to the Framework, or if the outcomes of this proceeding (assuming relevant Frameworks changes are identified) would then be assessed in a separate generic proceeding on the OEB's Framework for the Assessment of Distributor Gas Supply Plans.

Policy Interests:

Please see above. Pollution Probe is also interested to ensure that the Gas Supply Plan adequately balances economic (e.g. Ratepayer) and policy implications while ensuring the elements in the plan enable an effective and efficient energy transition.

Hearings:

Based on the May 15, 2025 Stakeholder consultation session for this proceeding, Pollution Probe understands that the OEB is planning an oral hearing schedule for this proceeding. Pollution Probe supports that approach.

Evidence:

Pollution Probe does not intend to commission expert evidence at this time. However, based on the issues outlined in the application and May 2025 Stakeholder session, Pollution Probe may provide relevant materials to the OEB during the proceeding. No specific approvals are required to enable this approach.

Coordination with Other Intervenor:

Pollution Probe has been an active and valuable participant in OEB proceedings and will continue to coordinate its activities with impacted consumers, intervenors and other parties as appropriate.
