Environmental Defence has been granted intervenor status in the following proceedings for the last 12 months:

Environmental Defence was denied intervenor status in one proceeding in the last 24 months (EB-2024-0193 - Enbridge DSM DVA).

## Issues:

Environmental Defence wishes to address all the key issues in this proceeding and participate in all aspects of the proceeding, including:

- The interplay between gas supply planning and the potential need for capital projects (e.g. shifting supply from the mainline to the Dawn-Parkway system, and whether that could

contribute to the need for capacity expansion project);

- Demand forecasts, and whether variances from the forecast are a cost risk with respect to gas supply planning;
- Whether Canadian supply should be prioritized;
- The appropriateness of any proposals relating to so-called responsibly sourced gas and other environmental certifications;
- Other topics canvassed by Environmental Defence in previous gas supply planning; and
- Other topics that may arise upon further review of the Applicant's materials and the discovery process.

## **Policy Interests:**

Environmental Defence seeks participant status and costs eligibility as a leading environmental organization that represents both the public interest in environmental protection and the interests of consumers whose energy bills can be reduced through measures that lower both costs and environmental impacts.

Environmental Defence was an intervenor in the Annual Update proceedings for the previous Gas Supply Plan (i.e. EB-2024-0067, EB-2022-0072 and EB-2021-0004).

## **Hearings:**

Environmental Defence requests the opportunity to make submissions on the type of hearing following receipt of the interrogatory responses.

## **Evidence:**

Environmental Defence does not intend to file evidence.

## **Coordination with Other Intervenors:**

Environmental Defence intends to coordinate with other intervenors, as it has on other OEB proceedings.

## **Cost Awards:**

Environmental Defence is eligible for a cost award primarily under s. 3.03(b) of the Practice Direction as it primarily represents an interest or policy perspective relevant to the Board's mandate and to the proceeding for which cost award eligibility is sought, namely environmental and climate protection. In addition, with respect to s. 3.03(a) of the practice direction, Environmental Defence also represents the interests of consumers whose energy bills can be reduced through measures that lower both costs and environmental impacts.

Environmental Defence will participate in English.
