Preamble:

EGI provides average bill impacts for residential customers by zone and rate class, including with respect to the proposed rate mitigation.

EGI notes that the total annual bill impacts for a typical residential sales service customer in the first year of implementation in 2027 result in:

- an increase of \$16.46 (or 1.3% of total bill) for a Rate 1 customer in the EGD rate zone;
- a decrease of \$35.51 (or 2.9% of total bill) for a Rate 01 customer in the Union North West rate zone;
- a decrease of \$199.73 (or 14.2% of total bill) for a Rate 01 customer in the Union North East rate zone; and
- an increase of \$22.84 (or 2.0% of total bill) for a Rate M1 customer in the Union South rate zone.
- a) Please confirm that GFN is located in the Union North West rate zone. If that assumption is incorrect, please replace references below to the Union North West rate zone with the rate zone applicable to GFN.
- b) Please confirm the rate classes that will apply in GFN's community should EGI's proposals be accepted.
- c) Please confirm the expected rate implications within GFN's community should EGI's proposals be accepted, as well as the available calculations and assumptions behind those numbers.
- d) Please explain how GFN's circumstances as a remote community affects the anticipated rate impacts that the community would see.
- e) Excluding immaterial considerations, please identify any characteristics of GFN's community that <u>will likely</u> result in bill impacts that are different from EGI's estimates for the Union North West rate zone more broadly.
- f) Excluding immaterial considerations, please identify any characteristics of GFN's community that <u>could</u> potentially result in bill impacts that are different from EGI's estimates for the Union North West rate zone more broadly.
- g) Please confirm the number of First Nation communities located in the Union North West rate zone who: a) generally share similar characteristics to GFN's from the perspective of their usage of EGI's services; and b) will likely experience similar bill impacts should EGI's proposals be accepted.

h) Please confirm the number of EGI customers located in the communities identified in your answer to the previous question.
