Reference 2) is an April 24, 2024 EGI open season posting for Rate 332 transportation service for 35,000 GJ/d of Parkway to Albion existing capacity for a minimum one (1) year term.

- a) Please provide the current OEB approved Parkway to Albion King's North Transportation Service Tariff for Rate 332 service, including the complete Rate 332 General Terms and Conditions as well as the FT Service Schedule and Form of FT Service Agreement.
 - b) Please provide the EGI Rate 332 Open Season posting from Reference 2).
 - c) In the FT Service Schedule provided in a), please confirm that Section 2.1 c) – Availability provides for the availability of FT service to shippers for an initial term of at least one (1) year for Service Agreements pertaining to Albion Pipeline Capacity that was not previously offered by Transporter in an Open Season and not created upon construction of the initial facilities for the Albion Pipeline or construction of Albion Pipeline Expansion Facilities. If not confirmed, please explain.
 - d) Please confirm that there is no provision included in the proposed Ex-Franchise Transportation Services General Terms and Conditions for harmonized Rate E70 from Reference 1) that provides for the availability of Rate E70 service to shippers for an initial term of at least one (1) year for Service Agreements pertaining to Albion Pipeline Capacity that was not previously offered by Transporter in an Open Season and not created upon construction of the initial facilities for the Albion Pipeline or construction of Albion Pipeline Expansion Facilities. If not confirmed, please explain.
 - e) Please discuss EGI's willingness to amend, through an update to its evidence in this proceeding, the proposed Ex-Franchise Transportation

Services General Terms and Conditions for harmonized Rate E70 from Reference 1) to provide for the availability of Rate E70 service to shippers on the Albion Pipeline on the same terms and conditions (i.e., for a term of at least one year and for the same type of capacity) as provided for in the current Rate 332 FT Service Schedule Section 2.1 c).

If EGI is willing to make such an amendment, please discuss the process and timing to do so.
