Re: EB-2023-0011 - Enbridge Rates Phase 2 - HRAI Cost Claim

We are counsel to the Heating, Refrigeration and Air Conditioning Institute ("HRAI"). Attached please find HRAI's cost claim in this matter on the OEB's form, with accompanying detailed dockets.

HRAI's involvement in this proceeding was on a discrete issue, Enbridge Sustain. As a result, much of the work was on a separate track from the issues that were the focus of the other intervenors.

From the outset, there were extra procedural steps because the Applicant opposed the involvement of HRAI, then opposed issues related to HRAI's concerns, and then opposed provision of basic information needed to deal with those issues. Eventually a substantial amount of information was provided, mostly through agreement between the parties, and much of it protected by confidentiality.

HRAI did submit interrogatories, which were ultimately answered after a formal Motion for Answers was filed. HRAI also participated in part of the Technical Conference. Several hundred pages of undertakings were provided as a result of the Technical Conference.

HRAI did participate in part of the main ADR, but mostly the ADR on the Enbridge Sustain issues took place on a separate track, with direct negotiations between the Applicant and HRAI. This resulted in a complete settlement of what had been, to that point, highly contentious areas of dispute between the Applicant and HRAI.

There has been significant overlap between intervention dispute, evidence review, issues list, interrogatories, technical conference, motion for answers, confidentiality claim, and settlement. We have attempted to allocate the overlapping time in a reasonable manner reflecting the emphasis of each activity at any point in time, so that all time is only included in one category.

A substantial amount of work on this matter (38.8 hours) was carried out prior to the intervention in Phase 2 of this proceeding. Those dockets are included for information purposes, but are separated

from the work on the Application itself, and have not been included in the hours on the Cost Claim Form.

The Enbridge Sustain issue engaged the entire HVAC community in Ontario, as it was seen as an existential threat to the independence of HVAC contractors around the province. The OEB will be aware that the proposed new Enbridge business was expected to be very substantial, and could have had far-reaching impacts. In fact, during the course of the proceeding Enbridge changed the structure of Enbridge Sustain, so that it went from being an unregulated activity within the utility to a separately incorporated affiliate.

Through this intervention, and the co-operation of the Applicant and its counsel, the entry of the Enbridge group of companies into HVAC contracting was adjusted so that the concerns of both the contractors and the Enbridge companies were taken into account. At all times in this proceeding, the interests of the ratepayers were kept in focus by all parties, and the intention is that they will be protected through the terms of the settlement.

HRAI therefore submits that it participated responsibly in this proceeding with a view to assisting the Commissioners and the other parties, and it is appropriate to order full reimbursement of HRAI's reasonably incurred costs for that participation.
