EB-2024-0319 – Hydro One Networks Inc. s.99 Waasigan Phase 1 Expropriation Application – Summary of General Record Keeping for Project Lands

In accordance with Condition #6 of the Conditions of Approval of the Ontario Energy Board ("OEB" or "Board") Decision and Order in this proceeding, dated June 10, 2025 ("Decision and Order") for Phase 1 of the Waasigan Project ("the Project"), Hydro One Networks Inc. ("Hydro One") is providing a summary of the general record keeping requirements it will implement for all Project lands.

As articulated in the Decision and Order, the general record keeping requirements that will be implemented for the execution of Project construction are consistent irrespective of whether land has been secured via expropriation or voluntarily. Similarly, the general record keeping requirements that will be implemented for the construction of the Project will align with the general reporting requirements implemented for all other Hydro One transmission infrastructure as there are no material differences between this Project and any other Hydro One transmission infrastructure with respect to general record keeping requirements.

When construction work is carried out on Project land interests owned by Hydro One it maintains communication with affected fee simple property owners. As outlined in Condition #2 of the Decision and Order, during construction, Hydro One will use all reasonable efforts to provide oral and written notice to the fee simple owners by providing a minimum of 48-hours notification prior to the initial entry onto the property. Hydro One will maintain records of all provided notices. Further, Hydro One will monitor ongoing construction work and engagements with affected property owners, including the tracking of any notable matters expressed by affected fee simple property owners and any subsequent response. On completion of construction work on the landowner's property Hydro One will notify the landowner the work is complete.

Hydro One manages the total costs of securing property rights for transmission projects, including administration costs, with a focus on reducing ratepayer costs. The above general record keeping practice is not expected to result in any incremental costs to ratepayers and Hydro One trusts it satisfactorily addresses the OEB's outlined request for providing assurance of the Condition, given it has been adequate to address the balance of Hydro One's property needs across the province.
