## Issues:

Members and supporters of Energy Probe are customers of Enbridge Gas. The rates they pay will be impacted by the outcome of this proceeding.

## Policy Interests:

Energy Probe believes that gas consumers should not be forced to subsidize political objectives such as energy transition or indigenous reconciliation. In particular Energy Probe's policy interest will be focused on the following issue.

Does the 5-year gas supply plan appropriately address the gas supply plan criteria set out in the OEB's Framework for the Assessment of Gas Distributor Gas Supply Plans (Framework): d. Achieving public policy objectives.

## **Hearings:**

Energy Probe has no good reason for having a specific form of hearing.

## **Evidence:**

Energy Probe does not intend to file evidence in this proceeding.

## **Coordination with Other Intervenors:**

Energy Probe intends to coordinate its work with other intervenors to avoid any duplication of interrogatories or questions during the technical conference or the hearing.
