Re: EB-2025-0073 - Enbridge Gas Inc. (EGI) Mississauga Reinforcement Project Leave to

Construct

Industrial Gas Users Association (IGUA) Request for Late Intervention

We write as counsel to IGUA to request late intervention in the captioned proceeding.

## Nature of IGUA's Interest

IGUA represents EGI's largest volume gas customers. IGUA's Frequent Intervenor Filing, which provides details of IGUA's general interest in OEB matters and governance mechanisms related thereto, can be found <a href="here">here</a>.

One of the EGI customers for whom the expansion that is the subject of this proceeding has been developed – Petro-Canada Lubricants Inc. (PCLI) - is an IGUA member. EGI's prefiled material indicates that the proposed expansion supports PCLI's decarbonization initiatives, while respecting the beneficiary pays principle. These are two broader principles which IGUA supports.

We have reviewed EGI's pre-filed material. Based on that review, and subject to development of the record herein, we anticipate that IGUA will ultimately provide brief submissions in support of the proposal on the basis of the principles noted above. On the basis of the current record a written hearing would be appropriate from our perspective.

## Request for Cost Eligibility

IGUA requests that it be determined eligible to apply for an award of its reasonably incurred costs for participation in this matter. IGUA has consistently been determined to be eligible for an award of its reasonably incurred costs as representative of the direct interests of Ontario's largest volume gas consumers (i.e. ratepayers) in relation to gas services that are regulated by the OEB.



In this instance IGUA's intervention will focus on the broader principles noted above, which IGUA has consistently supported. In keeping with what we anticipate will be a discreet, but in IGUA's view important, contribution herein, we anticipate modest costs associated with IGUA's participation.

## Late Intervention

We apologize for filing this intervention request late. We note that no Procedural Order has yet been issued in this matter and so the granting of IGUA's late intervention request should not delay the progress of this proceeding or otherwise prejudice any party or inconvenience the OEB. We have advised EGI of our intention to file this late intervention request and we understand that EGI has no objection thereto.

#### Conclusion

We appreciate the Board's consideration of this request.
