Re: Distribution Customer Connections Review (EB-2025-0204) ENWIN Utilities Ltd. Working Group Nomination

On July 3, 2025, the Ontario Energy Board (OEB) issued a letter regarding the launch of a comprehensive review of electricity distributor processes and requirements for connecting load customers. The OEB noted this review is in response to stakeholder feedback and the Minister of Energy and Mines' Integrated Energy Plan Directive, which calls on the OEB to conduct a review of electricity distributor connection procedures and report back by December 31 of this year.

To support this work, OEB staff are intending to establish a technical working group with representatives of both customers and distributors. Interested stakeholders were requested to submit nominations for the working group by July 21, 2025.

In consideration of the above, ENWIN Utilities Ltd. (ENWIN) hereby nominates Marvio Vinhaes, Director Engineering (Hydro), to participate in the working group.
