Electricity Transmission Revenue Requirement Change (EB-2008-0272)
Great Lakes Power Transmission LP Letter of Intervention**

We are legal counsel to Great Lakes Power Transmission LP ("GLPTLP"). We are writing on behalf of GLPTLP to request intervenor status in Hydro One's transmission rate application (EB-2008-0272).

GLPTLP is a licensed electricity transmitter (ET-2007-0649) that recovers its revenue requirement through the Board-approved provincial uniform transmission rates. Since any adjustment to those rates could impact the recovery of GLPTLP's revenue requirement, GLPTLP has a substantial interest in this proceeding.

GLPTLP intends to actively participate in all aspects of this proceeding and, to this end, reserves the right to be heard, to appear by or with counsel, to cross examine on all subject matters in this hearing that may relate to its interest, to advance evidence on specific matters relevant to this proceeding and to present argument.

GLPTLP takes no position on whether the proceeding is conducted by way of oral or written hearing and does not intend to seek an award of costs in this proceeding.
