**LETTER OF DIRECTION**

**Re: Enbridge Gas Inc. (Enbridge Gas)  
2026 Rates Application

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas's 2026 Natural Gas Distribution Rates application (Notice). Please note that you must comply with the directions in paragraphs 1 to 4 below prior to **August 15, 2025**. You are directed:

1. To post the enclosed English and French versions of the Notices, the application and evidence, and any amendments thereto, on Enbridge Gas's website.
2. To arrange for the service of the enclosed English and French versions of the Notices, the application and evidence on all intervenors in Enbridge Gas's proceedings EB-2022-0200, EB-2024-0111 and EB-2025-0064.
3. To arrange for service of the enclosed English and French versions of the Notices on customers for whom Enbridge Gas has an email address and the appropriate permissions to use the email address to send utility or regulatory information, together with the following email message:

"Enbridge Gas Inc. has applied to the Ontario Energy Board to change our natural gas distribution rates. Please review the Ontario Energy Board's Notice of Hearing to learn more and to find out how you can participate in the Ontario Energy Board's hearing."

5. To provide a copy of the English and French versions of the Notices, the application and evidence, and any amendments thereto, to anyone requesting the material.
6. To file with the OEB an affidavit confirming that the steps set out in paragraphs 1 through 4 have been completed.

You are further directed not to include any documents or materials when serving or publishing the Notices other than documents or materials expressly required by this letter of direction.
