Cost Awards:

Minogi and Three Fires each hereby request cost eligibility in this proceeding. Minogi and Three Fires are each, in accordance with s. 3.03(b) of the Board's Practice Direction on Cost Awards, eligible to seek an award of costs as they each primarily represent an interest or policy perspective that is relevant to the Board's mandate and to the proceeding.

Minogi and Three Fires each represent the interests of a unique and otherwise unrepresented set of First Nation energy customers and consumers in Ontario and are committed to ensuring that they are served through access to an affordable, reliable, sustainable, and modern natural gas service. Minogi and Three Fires request an award of costs in this proceeding on the basis that their comments and participation serve a direct interest and policy perspective that is relevant to the Board's mandate and pressing for Ontario's energy consumers. The Board has granted Minogi and Three Fires cost eligibility in several Board proceedings, including each of those referred to above in section 2.

Minogi and Three Fires therefore submit that it is appropriate for the Board to award both Minogi and Three Fires costs in the context of this proceeding, and hereby request cost eligibility.
