Further to the Ontario Energy Board's (OEB) acknowledgement letter dated August 1, 2025, the OEB has completed its preliminary review of your 2025 Transmission Revenue Requirement application and will now commence the processing of your application. An employee of the OEB, to whom authority has been delegated under Section 6 of the *Ontario Energy Board Act, 1998*, intends to make a decision on the application without holding a hearing.

OEB staff will be in contact with you directly throughout the course of the proceeding and may have questions regarding the application that will require your prompt attention.

Please note that you are responsible for ensuring that all documents filed with the OEB, including responses to OEB staff questions and any other supporting evidence, **do not include "personal information"** as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*, unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.

Following these steps, the delegated decision maker will provide you with a draft of their proposed decision. You will be given seven days within which to provide comments on the draft decision. The delegated decision maker will then consider your comments, if any, and issue a final decision.
