#### **DECISION AND ORDER**

Umbata Falls, Limited Partnership (Umbata Falls), Glen Miller Power, Limited Partnership (Glen Miller) and Trent-Severn Power, Limited Partnership (Trent-Severn) filed applications with the Ontario Energy Board (OEB) on July 21, 2025, under section 60 of the *Ontario Energy Board Act, 1998* (OEB Act), for renewals of their electricity generation licences.

Umbata Falls (EG-2005-0319) and Glen Miller's (EG-2005-0324) electricity generation licences are set to expire on September 8, 2025. Trent-Severn's (EG-2005-0325) electricity generation licence is set to expire on September 18, 2025. All three applicants are owned by Innergex Renewable Energy Inc.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

Umbata Falls owns one generation facility located in Marathon, Ontario. Glen Miller owns one generation facility located near Trenton, Ontario and Trent-Severn owns one generation facility in Batawa, Ontario.

After considering the applications and assessing the technical capability and financial viability of the applicants, the OEB finds that it is in the public interest to grant the applications and issue electricity generation licences to Umbata Falls, Limited Partnership, Glen Miller Power, Limited Partnership and Trent-Severn Power, Limited Partnership.
