## Issues:

We represent residential consumers of natural gas. The outcome of this proceeding will impact the rates that residential consumers pay for natural gas in Enbridge Gas Inc.'s service territory. We are materially impacted by the outcome of this proceeding. We are specifically interested in the request to adjust rates in 2026 (including the proposed Z-factor).

## Policy Interests:

We represent ratepayers and not a policy interest.

## Hearings:

The Council is of the view that it is premature to determine whether the application should proceed by way of an oral or written proceeding.

The Council does not intend to file evidence in this proceeding.
