**Application for a Certificate of Public Convenience and Necessity
for the City of Mississauga**

1 OVERVIEW

Through this Decision and Order, the Ontario Energy Board (OEB) approves an application filed by Enbridge Gas Inc. (Enbridge Gas) for a new certificate of public convenience and necessity (certificate) for the City of Mississauga. This new certificate is required merely to reflect changes to the municipal boundaries of the City of Mississauga.

2 CONTEXT AND PROCESS

Enbridge Gas filed an application with the OEB on May 29, 2025, under section 8 of the *Municipal Franchises Act*. The application is for an order approving a new certificate of public convenience and necessity to construct works to supply natural gas in the City of Mississauga.

The OEB held a written hearing. A notice of hearing was published in the www.mississauga.com website from June 23 to June 28, 2025 and in the *Toronto Star* newspaper on June 25, 2025 and in the *Toronto L'Express* newspaper on June 28, 2025. The notice of hearing was also posted on Enbridge Gas's website. No one sought to intervene or otherwise participate in the proceeding.

In this Decision and Order, a reference to the City of Mississauga is a reference to the municipal corporation or its geographic area, as the context requires.

This Decision and Order is being issued under delegated authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (OEB Act).

3 APPLICATION

Enbridge Gas is a corporation incorporated under the laws of the Province of Ontario, with its offices in the City of Toronto and the Municipality of Chatham-Kent.

The City of Mississauga is a municipal corporation incorporated under the laws of the Province of Ontario. It is a lower-tier municipality located in the Regional Municipality of Peel.

The Town of Mississauga, first incorporated in 1965, was reincorporated as the City of Mississauga in 1974, adding the communities of Port Credit and Streetsville. On January 1, 2010, the Town of Milton sold 400 hectares of land to the City of Mississauga in a corridor of land along Ninth Line between Highway 403/401 along Highway 407.¹ As a result, the border of the City was moved westward from Ninth Line to Highway 407.

Enbridge Gas has a certificate dated June 10, 2008 for the Town of Milton² which includes authority to service the annexed land and a certificate dated July 8, 2010 for the City of Mississauga.³ Although the 2010 certificate for the City of Mississauga was issued after the annexation, it does not include the authority to service this annexed land, as this area was considered a service area of Union Gas Limited at that time. After Enbridge Gas Distribution Inc. and Union Gas Limited amalgamated effective January 1, 2019 to become Enbridge Gas Inc., both certificates were assumed by Enbridge Gas.

In the light of foregoing, Enbridge Gas is authorized to serve the entire geographic area of the City of Mississauga, as it is currently constituted, through two existing certificates.

Through the application, Enbridge Gas seeks an order of the OEB cancelling EB-2010-0189 relating to the City of Mississauga, and replacing it with a new certificate to construct works to supply natural gas in the City of Mississauga as it is currently constituted. Enbridge Gas states that it is not aware of any other person holding a certificate for any part of the current City of Mississauga.

Enbridge Gas also filed a separate application for an order approving a new certificate for the Town of Milton as it is currently constituted.⁴ The Milton application likewise reflects municipal boundaries changes between the Town of Milton and the City of

Mississauga. In the light of foregoing, the OEB is issuing these two decisions concurrently to reflect the current municipal boundaries of these two municipalities.

Enbridge Gas has a 20-year franchise agreement with the City of Mississauga effective September 15, 2010.⁵ Enbridge Gas also has a franchise agreement with the Regional Municipality of Peel and franchise agreements with, and certificates for, the City of Brampton, the Town of Oakville, the Town of Milton and the Regional Municipality of Halton, each of which is immediately adjacent to the City of Mississauga. Enbridge Gas also has the right to use the City of Toronto's roads for the purpose of its gas works through an 1848 statute.⁶

4 FINDINGS

The OEB finds that it is in the public interest to approve Enbridge Gas's application for a certificate for the City of Mississauga. Enbridge Gas filed a complete application and provided notice of the hearing in the manner instructed by the OEB. No party intervened or otherwise objected the application.

The issuance of a new certificate for the City of Mississauga that is geographically aligned with its municipal borders is consistent with the intent of the OEB that certificate holders update service areas if boundaries of their existing certificate(s) are affected by municipal amalgamations, annexations, or name changes.⁷

A new certificate, attached as Schedule A to this Decision and Order, is granted to Enbridge Gas for the City of Mississauga. The new certificate cancels and supersedes Enbridge Gas's prior certificate authorization for the City of Mississauga.

The OEB is also issuing the decision on Enbridge Gas's request for a new certificate for the Town of Milton at the same time to reflect the current municipal boundaries.⁸

5 ORDER

IT IS ORDERED THAT:

1. A certificate of public convenience and necessity, attached as Schedule A, is granted to Enbridge Gas Inc. to construct works or supply natural gas in the City of Mississauga. A current map of the City of Mississauga is attached as Schedule B.
2. This certificate of public convenience and necessity cancels and supersedes: EB-2010-0189.
3. Enbridge Gas Inc. shall pay the OEB's costs of and incidental to this proceeding upon receipt of the OEB's invoice.
