# NOTICE OF A RATE HEARING

# EPCOR Natural Gas Limited Partnership has applied to change the gas distribution rates in its Aylmer service territory

EPCOR Natural Gas Limited Partnership (EPCOR Natural Gas) has applied to the Ontario Energy Board (OEB) to change the natural gas rates in its Aylmer service territory, effective January 1, 2026, based on an OEB-approved formula that is tied to inflation and other factors intended to promote efficiency.

EPCOR Natural Gas has also applied for approval to dispose of the balances in certain deferral and variance accounts and the increase of certain fixed monthly charges. If the application is approved as filed, the annual natural gas bill of a typical residential customer and a typical commercial customer in the Aylmer service territory would change by the following approximate amounts:

Rate Class	Annual Bill Change
R1 - Residential customers	-\$8.00 per year
R1 - General Service customers	-\$116.00 per year

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.



### YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenors. After the hearing, we will decide whether to approve the application.
