## NOTICE OF APPLICATION AND WRITTEN HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

# St. Thomas Energy Inc.

The Ontario Energy Board has received an application on November 5, 2008 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that St. Thomas Energy Inc. ("St. Thomas Energy") charges for electricity distribution, to be effective May 1, 2009. The Board has assigned the application file number EB-2008-0211. The Board's decision on this application may have an effect on all of St. Thomas Energy's customers. The application was filed under the Board's guidelines for 2<sup>nd</sup> Generation Incentive Regulation, which provides for a mechanistic and formulaic adjustment to rates between cost of service applications.

Any change to the rates that St. Thomas Energy charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

St. Thomas Energy indicates that if the application is approved as filed, a residential customer consuming 1,000 kWh per month would experience an approximate 4.3% increase in their delivery charges. This is a \$1.59 increase per month on their bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate 3.5% increase in their delivery charges. This is a \$2.23 increase per month on their bill.

### How to see St. Thomas Energy's Application

Copies of the application are available for inspection at the Board's office in Toronto and on its website, www.oeb.gov.on.ca, and at St. Thomas Energy's office and may be on its website.

### How to Participate in the Rate Proceeding

The Board intends to proceed with St. Thomas Energy's rate change application by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant at the addresses below no later than December 9, 2008. The Board will not be awarding costs in this matter.

Anyone who wishes information and material from the applicant that is in addition to the evidence filed with the Board and that is relevant to the hearing shall request it by written interrogatories filed with the Board and delivered to the applicant on or before December 23, 2008. The applicant shall file with the Board complete responses to the interrogatories and deliver them to all parties who asked interrogatories no later than January 6, 2009.

Anyone who wishes to make a submission on the application must file that written submission with the Board and deliver it to the applicant by January 20, 2009. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by February 17, 2009.
