Governance Structure:

A President and three Vice Presidents, who are elected for four-year terms, lead the PWU. This leadership provides support and direction for an extensive network of Stewards across Ontario. The PWU also has a highly skilled staff of more than 50 people including a collective bargaining research department, communications and government relations professionals, Health and Safety Staff Officers; a WSIB department to ensure fair compensation for workplace injuries or illnesses; experienced in-house legal counsel complete with a team of grievance specialists and more. In OEB proceedings, authority to instruct the PWU's representatives is typically delegated to a small number of individuals within the PWU who are able to provide instructions on an as needed and efficient basis.
