

# NOTICE OF A RATE HEARING

## Niagara-on-the-Lake Hydro Inc. has applied to increase its electricity distribution rates effective January 1, 2026

Niagara-on-the-Lake Hydro Inc. (Niagara-on-the-Lake Hydro) has applied to the Ontario Energy Board (OEB) to increase its electricity distribution rates effective January 1, 2026.

The requested rate changes are set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Niagara-on-the-Lake Hydro would see the following increases:

Customer Class	Monthly Rate
Residential (750 kWh)	\$0.93 per month
General Service less than 50kW (2,000 kWh)	\$2.20 per month

Other customers, including businesses, will also be affected. It is important to review the application carefully to determine whether you may be affected by the proposed changes.

Niagara-on-the-Lake Hydro has also requested approval:

- To adjust Retail Transmission Service Rates based on the proposed rates calculated in the 2026 Incentive Rate-Setting Mechanism Rate Generator Model (IRM model)
- To dispose of the balances in certain deferral and variance accounts including accounts that are collectively referred to as Group 2 accounts.

## YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
