

NOTICE OF A RATE HEARING

Alectra Utilities Corporation has applied to increase its electricity distribution rates effective January 1, 2026

Alectra Utilities Corporation (Alectra Utilities) has applied to the Ontario Energy Board (OEB) to increase its electricity distribution rates effective January 1, 2026.

The requested rate changes are set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Alectra Utilities would see the following increases:

Rate Zone (RZ)	Horizon RZ	Brampton RZ	PowerStream RZ	Enersource RZ	Guelph RZ
Residential (750 kWh)	\$1.08	\$0.98	\$1.13	\$0.98	\$1.18
General Service less than 50kW (2,000 kWh)	\$2.51	\$2.24	\$2.59	\$2.60	\$1.89

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

Alectra Utilities' request for approval also includes:

- Accounting orders for the establishment of two new deferral and variance accounts to track depreciation impacts related to expected changes to asset useful lives and changes to direct labour capitalization
- A request for recovery of Renewable Generation Connection Rate Protection funding for the Brampton, PowerStream, and Enersource Rate Zones
- Review of Return on Equity to determine if the Earning Sharing Mechanism is triggered for the Horizon, Brampton, PowerStream and Enersource Rate Zones (Year 8) and Guelph Rate Zone (Year 6)
- Assessment of the allocation methodology applied in the capitalization policy impact deferral accounts

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenorors. After the hearing, we will decide whether to approve the application.

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.
