Re: Regional and Bulk Electricity System Planning Review (EB-2025-0248) – Toronto Hydro-Electric System Limited Request to Participate in Advisory Group

On August 29, 2025 the OEB invited stakeholders to join an advisory group in support of its review of the regional and bulk planning process. The review is in direct response to the Minister of Energy and Mines' Integrated Energy Plan Directive, which requires the OEB to undertake a review of the regional and bulk electricity system planning processes and recommend enhancements that will make the processes more efficient, flexible, and responsive. The OEB intends the advisory group members to share their experience and provide insights to help shape the recommendations in the OEB's report to the Minister.

By way of this letter, Toronto Hydro nominates Mr. Kirk Huntley, Director of Investment Planning, as its representative to the OEB's advisory group. In his current role as Director of Investment Planning, Mr. Huntley is directly responsible for the Toronto Hydro's distribution system capital plan including non-wires, load, and generation capacity planning over the short and long term and also has broad experience in areas of substation and distribution system planning and design. Mr. Huntley holds a Bachelor's Degree in Engineering, and is a registered Professional Engineer in Ontario. Given his roles and experience, Toronto Hydro expects that Mr. Huntley will be able to assist the OEB with a broad range of issues that may arise during the course of this initiative.
