**Application for electricity distribution rates and other
charges effective January 1, 2026**

**PROCEDURAL ORDER NO. 1
September 24, 2025**

Centre Wellington Hydro Limited (Centre Wellington Hydro) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on August 14, 2025, under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to its electricity distribution rates to be effective January 1, 2026. Centre Wellington Hydro also applied for an Advanced Capital Module rate rider to recover the costs of the Fergus MS-5 Station, a new distribution station expected to be in service by the end of Q1 2026.

The application will be heard by commissioner: Patrick Moran.

A Notice of Hearing was issued on September 3, 2025. No persons applied for intervenor status.

The OEB is making provision for the following related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. OEB staff shall request any relevant information and documentation from Centre Wellington Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Centre Wellington Hydro, by **October 2, 2025**.
2. Centre Wellington Hydro shall file with the OEB complete written responses to the interrogatories by **October 15, 2025**.
3. Any written submissions by OEB staff shall be filed with the OEB and served on Centre Wellington Hydro by **October 28, 2025**.
4. Any reply submissions by Centre Wellington Hydro, shall be filed with the OEB by **November 11, 2025**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
