Issues:

The Service Area Amendment Application ("SAA") advanced by Wasaga Distribution Inc. ("WDI") for the connection of 400 45th Street South, Wasaga Beach, Ontario ("Subject Lands") falls within the existing service territory of Hydro One Networks Inc. ("Hydro One") and loss of the Subject Area will have an impact on Hydro One and/or Hydro One ratepayers. Hydro One's intervention will focus on all the principles defined in the Combined Distribution Service Area Amendments Proceeding – Ontario Energy Board docket RP-2003-0044 which Hydro One accepts as the standard issues in a service area amendment proceeding.
