The Ontario Energy Board (OEB) received your 2026 Distribution Rate Application on October 9, 2026.

Please note that you are responsible for ensuring that all of the documents filed with the OEB, including responses to OEB staff questions and any other supporting evidence, **does not include "personal information"** as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*, unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.

If any additional information is received from you in response to OEB staff questions, OEB staff will update the applicable models filed with your application, as necessary. All changes to the models will be documented and provided to you no later than December 11, 2025. OEB staff will also outline any additional information that you need to provide.

If you have any comments regarding the updated models, please provide them to your OEB case manager together with any additional information requested of you, by no later than January 8, 2026.

Following these steps, the OEB will provide you with a draft decision and, where possible, a draft rate order and applicable models. You will be given seven days within which to provide comments on the draft decision (and, in some circumstances, you may need to file a separate draft rate order). The OEB will consider your comments (if any), prior to issuing a final decision and rate order.
