

# NOTICE OF A RATE HEARING

## Lakeland Power Distribution Ltd. has applied to change its electricity distribution rates effective May 1, 2026

Lakeland Power Distribution Ltd. (Lakeland Power) has applied to the Ontario Energy Board (OEB) to change its electricity distribution rates effective May 1, 2026.

The requested rate adjustment is determined using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Lakeland Power would see the following changes:

| Customer Class                            | Monthly Rate      |
|-------------------------------------------|-------------------|
| Residential (750 kWh)                     | \$7.53 per month  |
| General Service less than 50kW (2000 kWh) | \$15.00 per month |

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

Lakeland Power has also requested:

- Approval for Z-factor fixed rate riders, related to a lightning storm that occurred on June 13, 2024
- Approval for Z-factor fixed rate riders, related to a severe ice storm that occurred on March 29, 2025

## YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic, and written. The OEB plans to proceed with a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

- Provide input on the hearing type (oral, electronic, or written)
- Apply to be an intervenor

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.

### PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
