**Application for electricity distribution rates and other
charges effective May 1, 2026**

**PROCEDURAL ORDER NO. 1
November 21, 2025**

Orangeville Hydro Limited (Orangeville Hydro) filed an incentive rate-setting mechanism application with the Ontario Energy Board (OEB) on October 9, 2025, under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval for changes to its electricity distribution rates to be effective May 1, 2026. Orangeville Hydro also applied for an exception to the IESO two-year limitation period to dispose certain deferral and variance accounts on an interim basis for fiscal years 2021 to 2024¹.

The application will be heard by commissioner: David Sword.

A Notice of Hearing was issued on October 28, 2025. No persons applied for intervenor status.

The OEB is making provision for the following related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. OEB staff shall request any relevant information and documentation from Orangeville Hydro that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Orangeville Hydro by **December 19, 2025**.
2. Orangeville Hydro shall file with the OEB complete written responses to the interrogatories by **January 16, 2026**.
3. Any written submissions by OEB staff shall be filed with the OEB and served on Orangeville Hydro by **January 30, 2026**.

4. Orangeville Hydro may file a written reply submission with the OEB by **February 17, 2026**.
