



**Enbridge Gas Inc.**

**Application for the disposition of the 2023 Demand Side  
Management Deferral and Variance Accounts**

**PROCEDURAL ORDER NO. 1  
November 28, 2025**

Enbridge Gas Inc. (Enbridge Gas) filed an application with the Ontario Energy Board (OEB) on October 15, 2025, under section 36 of the *Ontario Energy Board Act, 1998* seeking approval to dispose of amounts recorded in certain 2023 deferral and variance accounts (DVAs), related to the delivery of natural gas conservation and energy efficiency programs.

The application will be heard by commissioners: Allison Duff (presiding), Robert Dodds, and David Sword.

A Notice of Hearing was issued on November 7, 2025. Canadian Manufacturers & Exporters (CME), Ontario Greenhouse Vegetable Growers (OGVG) and School Energy Coalition (SEC) applied for intervenor status and cost eligibility.

No objection was received from Enbridge Gas.

CME, OGVG and SEC are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order. CME, OGVG and SEC are eligible to apply for an award of costs under the OEB's [Practice Direction on Cost Awards](#).

Cost eligible intervenors should be aware that the OEB will not generally allow the recovery of costs for the attendance of more than one representative of any party unless a compelling reason is provided when cost claims are filed.

The OEB is making provision for the following related to this proceeding. Further procedural orders may be issued by the OEB.

**THE ONTARIO ENERGY BOARD ORDERS THAT:**

1. OEB staff and intervenors shall request any relevant information and documentation from Enbridge Gas that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Enbridge Gas by **December 5, 2025**.
2. Enbridge Gas shall file with the OEB complete written responses to the interrogatories and serve them on all intervenors by **December 15, 2025**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
