
Re: Impala Canada Ltd. (Impala Canada) Application for Expropriation – Impala Line Ontario Energy Board File Number EB-2025-0286 – Impala Confirmation of Supplemental Service of Notice

We represent Impala Canada Ltd. (“**Impala**”) in relation to its application to the Ontario Energy Board (“**OEB**”) pursuant to section 99(1).2 of the *Ontario Energy Board Act, 1998*¹ for authority to expropriate certain interests in lands necessary for the operation and maintenance of a transmission line serving the Lac des Iles Mine (the “**Impala Line**”) (the “**Application**”).

On October 27, 2025, the OEB issued the Notice of Application and Hearing in relation to the Application (“**Notice**”) and directed Impala to serve the Notice on all those identified as having a direct or registered interest in the lands directly affected by the expropriation application. Impala fulfilled this requirement on November 10, 2025.

On November 25, 2025, Impala committed to provide supplemental service of the Notice to a registered holder of a mortgage interest in relation to the lands over which expropriation is sought in the Application. Impala maintains that the mortgage holder, Metropolitan Life Insurance Company, does not hold a direct or registered interest in the lands directly affected by the expropriation application. Please see attached affidavit of service providing confirmation of Impala’s fulfillment of its commitment to serve Metropolitan Life Insurance Company.

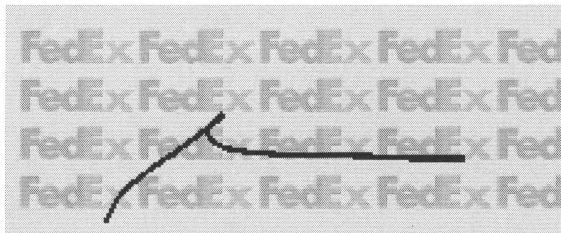
