



Enbridge Gas Inc.

**Application for leave to construct natural gas pipeline in
the community of Washago and surrounding areas in
the Township of Severn and the Town of Gravenhurst**

PROCEDURAL ORDER NO. 1
December 9, 2025

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on October 7, 2025, under section 90 and 97 of the *Ontario Energy Board Act, 1998*, for an order granting leave to construct approximately 22 kilometres of natural gas distribution pipelines and associated facilities in the community of Washago and surrounding areas in the Township of Severn and the Town of Gravenhurst. As part of the Natural Gas Expansion Program, the proposed natural gas pipeline will provide customers with access to safe, reliable, and affordable natural gas distribution services. Enbridge Gas has also applied to the OEB for approval of the form of land-use agreements it offers to landowners for the routing and construction of the project.

The application will be heard by commissioners: David Sword (presiding), Robert Dodds, and. Damien A. Côté

A Notice of Hearing was issued on October 31, 2025. No intervention requests were received by the OEB.

Interrogatories and Submissions

1. OEB staff shall request any relevant information and documentation from Enbridge Gas that is in addition to the evidence already filed, by written

interrogatories filed with the OEB and served on all parties by, **December 23, 2025**.

2. Enbridge Gas shall file with the OEB complete written responses to all interrogatories and serve them on OEB staff by **January 22, 2026**.
3. Any written submissions from OEB staff, shall be filed with the OEB and served on all parties by **February 5, 2026**.
4. Any written reply submissions from Enbridge Gas shall be filed with the OEB and served on OEB Staff by **February 19, 2026**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
