## Issues:

Minogi is actively engaged in matters and issues related to Ontario’s energy sector and the potential impacts on the interests of Mississaugas of Scugog Island First Nation ("MSIFN"), including as a participant in the Indigenous Working Group (“IWG”) established in Phase 1 of EGI’s 2024 rebasing application (EB-2022-0200). Minogi intends to make submissions, inter alia, on the Applicant’s evidence in respect of the IWG Report; and any other matters that promote or otherwise represent the interests of Minogi and MSIFN more generally.

## Policy Interests:

Minogi represents the interests of represents the interest of MSIFN. Minogi therefore believes this question is not applicable to it, but it is available to provide further information on request.

## Hearings:

Minogi does not currently take a position on this question.

## Evidence:

Minogi and Three Fires Group Inc. ("TFG") are currently considering whether they wish to file expert evidence, either on their own or in collaboration with other intervenors. Minogi and TFG will undertake and conclude the necessary conversations at the earliest possible date to determine their position. In the event Minogi and TFG wish to file evidence, they will seek Board approval at the earliest opportunity.

## Coordination with Other Intervenors:

Minogi and TFG intend to coordinate their participation in this proceeding in a manner similar to their coordination in previous OEB proceedings. Both Minogi and TFG will collaborate

with other intervenors as appropriate and as opportunities arise.

## **Cost Awards:**

Minogi hereby requests cost eligibility in this proceeding. Minogi is, in accordance with s. 3.03(b) of the Board's Practice Direction on Cost Awards, eligible to seek an award of costs as Minogi is a party that primarily represents an interest or policy perspective that is relevant to the Board's mandate and to the proceeding. Minogi represents the interests of a unique and otherwise unrepresented set of First Nation energy customers and consumers in Ontario and is committed to ensuring that they are served through access to an affordable, reliable, sustainable, and modern natural gas service. Minogi requests an award of costs in this proceeding on the basis that its comments and participation serve a direct interest and policy perspective that is relevant to the Board's mandate and pressing for Ontario's energy consumers. The Board has granted Minogi cost eligibility in several Board proceedings, including each and all of those referred to above in Section 2. Minogi therefore submits that it is appropriate for the Board to award Minogi costs in the context of this proceeding, and hereby requests cost eligibility.
