Subject: Gas-Electric Co-ordination and Information Sharing (EB-2025-0227)

We write as legal counsel to the Industrial Gas Users Association (IGUA) to indicate IGUA's interest in participating in the captioned matter. IGUA will be represented by the writer, whose contact information is set out below.

As representative of Ontario's largest volume gas consumers IGUA is a regular participant in OEB proceedings related to natural gas rates, facilities, services and policy. In recent years, IGUA has actively participated in consideration by the OEB of the future role of natural gas and the maintenance of a viable natural gas delivery system for gas dependant customers while having due regard to risks of utility asset underutilization and mitigation of such risks. In Enbridge Gas Inc.'s (EGI) 2024 Rates rebasing application [EB-2022-0200] IGUA sponsored expert evidence [Exhibit M8] which, among other things, explored the need for EGI to more proactively plan for an uncertain future and the advancement of electrification. This evidence materially contributed to the Hearing Panel's deliberations, and to the Board's decision and directions in that case.

IGUA requests that it be determined eligible to apply for an award of its reasonably incurred costs of participation in this matter. As a party primarily representing the direct interests of Ontario's largest volume gas consumers, IGUA has traditionally been found eligible to apply for a cost award.
