#### **Staff Question-4**

**Reference 1:** 2026 Application

**Reference 2:** Rate Generator Model, Tab 3, Continuity Schedule (Cell BU 33)

#### **Preamble:**

As per Reference 1, OEB staff observes that Bluewater has not requested the disposition of Account 1595. However, as per Reference 2, Bluewater has indicated "Yes" for the disposition of Account 1595 for year 2021.

#### **Question(s):**

- a. Please confirm OEB staff's observation and provide clarification if the disposition is sought. Please update the Rate Generator Model and/or the Application, if applicable.

#### **Response:**

Bluewater indicated "yes" for account disposition on Tab 3 for 1595 for year 2021 as doing so is necessary to include this amount in the Total Claim column, along with the other account balances that are also eligible for to be claimed for recovery. The Total Claim amount is then used to calculate the threshold test on Tab 4. If Bluewater indicated "no" for account disposition for 1595 for year 2021, the Threshold Test on

Tab 4 would be based on an incorrect amount.

For clarity, in the revised rate generator model submitted with this response, the total claim of all Group 1 Accounts is \$145,645, including \$31,184 for account 1595 (2021). However, this amount does not meet the threshold test and therefore Bluewater is not seeking disposition in this application.

Hi Jody and Alanna,

It was nice speaking with you both today. Please find below the minutes of the meeting and confirm the same:

1. Bluewater requested clarification on Staff Question 3 regarding the input of values in the Rate Generator Model. OEB staff clarified that the relevant values must be populated for all applicable years, beginning with 2020.
2. For Staff Question 4, Bluewater stated that selecting "No" for Cell BU33 causes the "Total Group 1 balance including Account 1568 requested for disposition" in Cell BT48, to show an inaccurate value. This also affects the threshold test in Tab 4 of the Rate Generator Model. OEB staff has asked Bluewater to provide a detailed description of their concern so that staff can respond accurately.
