LETTER OF DIRECTION

**Re: Ontario Power Generation Inc. (OPG) and DNNP LP
Application for 2027-2031 Payment Amounts
Ontario Energy Board File Number: EB-2025-0297**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Ontario Power Generation and DNNP LP's application for 2027-2031 Payment Amounts (Notice). The Notice will be published by the OEB in English and French in both online and hard copy newspapers, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 to 3 below prior to **January 26, 2026**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

You are directed:

1. To post the enclosed Notices, the application and evidence, and any amendments thereto, on Ontario Power Generation's website.
2. To arrange for the service of the enclosed Notices and Exhibit A1-3-1 Summary of Application directly on all intervenors of record in Ontario Power Generation's previous payment amount application, EB-2020-0290.

It is acceptable to serve the evidence by e-mail provided the past intervenor has stated its preference for the same.

3. To post the following message on all of the following social media accounts that Ontario Power Generation may have, including X (formerly Twitter), LinkedIn, Facebook, and/or Instagram account:

- a) “We have applied to the Ontario Energy Board to increase our payment amounts. Learn more. Have your say.”
- b) « Nous avons déposé une requête auprès de @OntEnergyBoard afin d’augmenter montants de paiement. Soyez mieux renseigné. Donnez votre opinion. »

The post(s) is required to include the Online Ad and to provide a link to the Notices as posted on Ontario Power Generation’s website in accordance with paragraph 1.

4. To provide a copy of the Notices, the application and evidence, and any amendments thereto, to anyone requesting the material.
5. To file with the OEB an affidavit confirming that the steps set out in paragraphs 1 through 3 have been completed.

You are further directed not to include any documents or materials when serving or publishing the Notices other than documents or materials expressly required by this letter of direction.

The OEB is currently conducting a preliminary review of your application. Upon completion of this review, the OEB will communicate the next steps in the process.
