We are counsel to 1170367 Ontario Inc. and Nyon Oil Inc. I was advised today by OEB counsel, Ms. Stephanie Pope, that Hydro One has filed a letter of objection to our clients' Request to Intervene in EB2025-0290. That objection was not sent to us by Hydro One, nor were we copied on its filing with the OEB. There is no publicly available webpage under the "Major Applications" heading or the "Section 92 Leave to Construct" heading on the OEB's website. Accordingly, we were not aware of the objection until I received the call from Ms. Pope today, and we still have not received a copy of the objection letter.
