Staff Question-8

Ref: EB-2025-0010, 2026 Rate Generator Model (RGM)

Preamble:

In Tab 3 of the referenced file, rows 30 and 31 are currently hidden, and cells BU30 and BU31 are set to "Yes" for *Disposition and Recovery/Refund of Regulatory Balances (2009)* and *Disposition and Recovery/Refund of Regulatory Balances (2019 and pre-2019)*. As a result, the 1595 Recovery Proportion (2019 and pre-2019) column in Tab 4 is enabled and is populated with 0% values. However, the balances for both of these accounts are zero.

OEB staff have set the values for these two accounts to "No".

Staff Question-9

Ref 1: EB-2025-0010, GA Analysis Workform (2026 Rate Application)

Ref 2: EB-2025-0010, Rate Generator Model, Tab 3. Continuity Schedule

Preamble:

In Tab GA2024 of Reference 1, the amount reported in cell C75 is \$68,176, whereas Reference 2 reports an amount of \$150,227 in cell BD29. These amounts are not aligned; however, alignment is expected, as both figures represent the same underlying activity.

Question(s):

- a) Please confirm the amounts reported in Cell C75 of Tab GA2024 in Reference 1 and Cell BD29 of Reference 2.
 - i. If confirmed, please reconcile and explain the discrepancy between the two amounts, and revise the references to ensure consistency.

Staff Question-10

Ref: EB-2025-0010, GA Analysis Workform, Tab GA2024

Preamble:

In Note 2 of the above reference, the RPP consumption (A) is reported as 63,424,927, whereas the corresponding value in the 2025 RRR filing is 63,424,297. The consumption data for Total Metered excluding WMP (C) and Non-RPP Class A (D) are consistent with the RRR filing.

In Note 4 of above reference, no explanation is provided in cells J77–J79, despite the corresponding cells under the Principal Adjustment column in the DVA Continuity Schedule being set to “No”.

In Note 5 of above reference, cell C65 is blank. However, an explanation is required in the associated text box if columns G and H for unbilled consumption are not used in the Note 4 table within the same tab.

Question(s):

- a) Please confirm the RPP (A) value reported in Cell D15 of the above reference, and reconcile the figures as necessary if the value is determined to be incorrect.
- b) Please confirm that the cells under Principal Adjustment in the DVA Continuity Schedule are set to “No”.
 - a. If confirmed, please provide explanations in the relevant cells under column J wherever an explanation is required.
- c) Please confirm that columns G and H for unbilled consumption are not used.
 - a. If confirmed, please provide an explanation.

Staff Question-11
