

# Annual Filing of Frequent Intervenor

## Intervenor Name:

Hydro One Networks Inc.

## Mandate and Objectives:

Hydro One Inc. - Hydro One or the Company, a subsidiary of Hydro One Ltd., operates extensive electricity transmission and distribution facilities throughout Ontario and delivers electricity safely and reliably to approximately 1.5 million customers, including residential, commercial and large industrial customers, Indigenous communities, and municipal utilities across the province of Ontario.

Hydro One is a major stakeholder in the Ontario energy sector and a regulated Ontario electricity distributor and transmitter.

## Membership of the Intervenor and Constituency Represented:

The subsidiaries represented include:

Hydro One Networks Inc. - HONI - an Ontario corporation that carries on the business, among other things, of owning and operating electricity transmission and distribution facilities in Ontario pursuant to licenses ET-2003-0035 and ED-2003-0043 from the Ontario Energy Board - the OEB.

Hydro One Remote Communities Inc. - HORCI - an integrated generation and distribution company licensed to generate and distribute electricity within 12 isolated communities and 15 grid-connected community in northern Ontario ED-2003-0037 and EG-2003-0138.

Hydro One Sault Ste. Marie LP - HOSSM - provides electricity transmission in the vicinity of Sault Ste. Marie, Ontario, under licence number ET-2007-0649 from the OEB.

B2M Limited Partnership - B2M LP - limited partnership licensed by the OEB, under licence number ET-2013-0078, to transmit electricity and carry on the business of owning and operating transmission facilities in southwestern Ontario. HONI holds an approximately 66 percent interest in B2M LP.

Niagara Reinforcement Limited Partnership - NRLP - licensed by the OEB, under licence

number ET-2018-0277, to transmit electricity and carry on the business of owning and operating the transmission facilities related to the Niagara Reinforcement Project in southwestern Ontario. HONI holds an approximately 55 percent interest in NRLP.

Chatham x Lakeshore Limited Partnership - CLLP - limited partnership licensed by the OEB, under licence number ET-2024-0147, to transmit electricity and carry on the business of owning and operating the transmission facilities in southwestern Ontario. As of December 31, 2025, HONI holds an approximately 80 percent interest in CLLP; however, this interest is expected to decrease as additional First Nations join the partnership.

## **Programs or Activities Carried Out by the Intervenor:**

Through its subsidiaries, Hydro One owns and operates approximately 30,000 circuit kilometres of high-voltage transmission lines and approximately 125,000 circuit kilometres of primary low-voltage distribution lines.

Hydro One's transmission business owns, operates and maintains Hydro One's transmission system, which accounts for approximately 94 percent of Ontario's transmission capacity based on total revenue requirement approved by the Ontario Energy Board - OEB. As of December 31, 2025, the Company's transmission business consists of the transmission system operated by subsidiaries of Hydro One, including Hydro One Networks Inc., HOSSM, as well as an approximately 66 percent interest in B2M LP, an approximately 55 percent interest in NRLP, and an approximately 80 percent interest in CLLP. The transmission business also includes an approximate 48% interest in the East-West Tie Limited Partnership. The Company's transmission business is rate-regulated and earns revenues mainly by charging transmission rates that are approved by the OEB.

Hydro One's distribution business is the largest in Ontario and consists of the distribution systems operated by Hydro One's subsidiaries, Hydro One Networks, and Hydro One Remotes. The Company's distribution business is rate-regulated and earns revenues mainly by charging distribution rates that are approved by the OEB, as well as amounts to recover the cost of purchased power.

Electricity – Rates, Natural Gas – Rates, Electricity – Leave to Construct, Natural Gas – Leave to Construct, OEB Consultations - Electricity, OEB Consultations – Natural Gas, OEB Policy Development, MAADs (Mergers, Amalgamations, Acquisitions and Divestitures)

## **Governance Structure:**

Intervenor requests are overseen by Hydro One's Regulatory Affairs department, which supports all subsidiaries under Hydro One. Regulatory Affairs will manage all communication and interface directly with the subsidiaries.
