Re: EB-2025-0055 – Alectra 2026 Rates – Revised SEC Cost Claim

We are counsel to the School Energy Coalition (“SEC”). Attached, please find the revised cost claim using OEB’s cost claim system correcting an error.

SEC divided responsibility for this proceeding between its consultant, Jane Scott, and its counsel. Ms. Scott had primary responsibility, with oversight and instructions provided by SEC counsel, Jay Shepherd. As the matter involved aspects relevant to the 2027 Custom IR proceeding, the undersigned, who has carriage of that matter for SEC, was required to provide certain input.

We note where dockets include both reviewing evidence and preparing interrogatories, time has been allocated 50% to each applicable activity category.
