Issues:

Members of CCMBC are commercial and industrial customers of the Applicant. The rates they pay will be impacted by the outcome of this proceeding. The specific issues of interest to CCMBC are the proposed rate harmonization of the Veridian and Whitby rate zones, the 2027 base year revenue requirement, the Custom Revenue Cap Index for setting rates from 2028 to 2031, and the clearing of the deferral and variance account balances.

Policy Interests:

CCMBC has no policy interest in this proceeding.

Hearings:

CCMBC does not believe that there is a good reason for having a specific form of hearing.

Evidence:

CCMBC does not intend to file evidence.

Coordination with Other Intervenors:

CCMBC intends to coordinate its efforts with intervenors who may have similar interests by sharing drafts of interrogatories and submissions to avoid duplication.

Cost Awards:

CCMBC is a non-profit organization which relies on membership fees and individual donations to help protect the interests of its member manufacturers and other businesses who are electricity consumers. CCMBC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of energy consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure and its Practice Direction on Cost Awards.

Language Preference:

CCMBC intends to participate in the proceeding using the English language.
