**Re: EB-2025-0312 – Elexicon Energy Inc. Distribution Rates Application Effective January 1, 2027 – Intervention Request**

The Quinte Manufacturers Association (QMA or Association) is requesting intervenor status in the Ontario Energy Board's above-noted proceeding regarding Elexicon Energy Inc.'s (Elexicon Energy) rebasing application to adjust its electricity distribution rates effective January 1, 2027.

QMA is an unfunded, industry-led association representing manufacturers and related companies across the Greater Bay of Quinte region which includes the cities of Belleville, Quinte West and the municipality of Brighton. Our membership spans a diverse industrial sector—from large multinational corporations to small and medium-sized enterprises—reflecting the full spectrum of manufacturing activity in the area. Elexicon Energy is the primary electricity distributor to our members who are typically General Service customers.

Manufacturing and related industries are the economic backbone of our region, generating over \$6 billion of the Bay of Quinte's \$12 billion total economic output. More than 11,000 people are employed in these sectors, making energy affordability and reliability critical to sustaining jobs, investment, and long-term growth.

The Association has a substantial interest in the outcome of this proceeding given the direct and material impact that Elexicon Energy Inc.'s distribution rates have on our members' operations and competitiveness. We intend to participate actively and responsibly in the review process including examining evidence, submitting any necessary interrogatories, providing comments or arguments, and coordinating with other intervenors as appropriate. The QMA is in support of an oral hearing in this proceeding.
