## Issues:

CCMBC is a coalition of more than 400 manufacturers and other businesses, most of whom are Ontario manufacturers. The rates they pay for natural gas will be impacted by the outcome of this proceeding. CCMBC was an intervenor in the EB-2024-0198 proceeding and supported the roll-over of commercial and industrial DSM programs and expects to support the continuation of these programs in this proceeding.

## Policy Interests:

CCMBC has no specific policy interest in this proceeding.

## Evidence:

CCMBC does not intend to file evidence.

## Coordination with Other Intervenors:
