Issues:

BOMA Toronto has an interest in all issues in this proceeding. Enbridge Gas Inc. (EGI)'s proposed 2027-2030 natural gas conservation plan ("DSM plan") in this proceeding consists of conservation programs for BOMA Toronto members. The EGI proposed DSM plan's associated rate impact will also affect BOMA Toronto members directly. BOMA Toronto represents multi-residential, industrial and commercial building owners' interests and will advocate for a portfolio of cost effective, accessible and efficient conservation programs for its members, while maintaining affordability.

Policy Interests:

The outcome of this proceeding is significantly relevant to BOMA Toronto's primary policy interests, which include energy transition and decarbonization, conservation and demand management and energy bill impacts for commercial customers.

Hearings:

Coordination with Other Intervenors:
